

Compliance Declaration on Substances and Materials (EU)

mdexx fan systems GmbH Weyhe, Germany

Statement

mdexx fan systems GmbH hereby confirms that the products manufactured and supplied by the company comply with the relevant requirements of REACH Regulation (EC) No. 1907/2006, the RoHS Directive 2011/65/EU including Delegated Directive (EU) 2015/863 and – where applicable – the SCIP notification obligations pursuant to the Waste Framework Directive. The products of mdexx fan systems GmbH are articles within the meaning of Article 3 of the REACH Regulation and do not intentionally release substances under normal or reasonably foreseeable conditions of use.

Within the supply chain, mdexx fan systems GmbH acts as a manufacturer of articles and – insofar as substances or mixtures (e.g. coatings, sealants, adhesives) are used – as a downstream user within the meaning of the REACH Regulation. The assessment of materials and components used is based on supplier declarations, material information and conformity documentation provided by the respective manufacturers (including motor and component suppliers). If an article contains substances listed on the current REACH Candidate List in a concentration exceeding 0.1 % (w/w), mdexx fan systems GmbH fulfils its statutory information obligations pursuant to Article 33 REACH. SCIP notifications are submitted in such cases in compliance with legal requirements. Supplier–specific SCIP reference numbers are not part of this declaration.

2. Purpose and Scope

This declaration describes the regulatory compliance of the products manufactured and supplied by mdexx fan systems GmbH with regard to substances and materials in accordance with the applicable legislation of the European Union. It applies to products classified as articles within the meaning of Article 3 of the REACH Regulation, including the resulting information and notification obligations (e.g. SCIP), where applicable.

Role of mdexx fan systems GmbH

mdexx fan systems GmbH is a manufacturer of industrial fans. The company does not manufacture chemical substances or mixtures and does not intentionally release substances, but exclusively uses premanufactured materials and components supplied by external suppliers.

4. REACH Regulation (EC) No. 1907/2006

mdexx fan systems GmbH fulfils its obligations under the REACH Regulation, including the information obligations pursuant to Article 33 concerning substances of very high concern (SVHC). Based on supplier information available at the time of issuance of this declaration, no substances listed on the ECHA Candidate List are known to be present in our products above the threshold of 0.1% (w/w) per article. Where applicable, the legally required information pursuant to Article 33 REACH is provided. SCIP notifications are submitted in such cases in compliance with legal requirements.



5. RoHS Directive 2011/65/EU

For products falling within the scope of Directive 2011/65/EU, as amended, including Delegated Directive (EU) 2015/863, mdexx fan systems GmbH confirms compliance with the substance restrictions set out in Annex II. This confirmation is based on supplier declarations, technical documentation and – where applicable – documented exemptions pursuant to Annex III and Annex IV of the Directive. Products outside the scope of the RoHS Directive are not subject to these requirements.

6. PFAS

Under the current EU legal framework, there is no general obligation to declare products as 'PFAS-free'. Based on currently available supplier information, there are no indications of an intentional use of PFAS in the products supplied. Regulatory developments are continuously monitored; this declaration will be reviewed and updated if required.

7. EUDR - Regulation (EU) 2023/1115

Regulation (EU) 2023/1115 on deforestation-free supply chains applies to certain raw materials and products derived therefrom, in particular wood and natural rubber. The products supplied by mdexx fan systems GmbH are industrial fans and associated components made of metal and technical materials. Wood, natural rubber or other raw materials falling within the scope of the EUDR are not used. On this basis, the products currently do not fall within the material scope of the EUDR.

8. Supporting Documentation

Supporting supplier declarations, including REACH and RoHS documentation, are obtained, checked for plausibility and retained within the technical documentation. Such documentation can be made available upon justified request.

9. Disclaimer

This declaration is issued to the best of our knowledge and based on the information available from the supply chain at the time of issuance. mdexx fan systems GmbH assumes no express or implied warranties beyond the scope of this declaration and reserves the right to update this declaration should new information become available.
